Although scheduled to begin at 10:00 a.m., the meeting shall not convene until a quorum has been established. Proxies will be accepted by the **Credentials Committee** up until **9:00 a.m.**, one hour before the meeting. A delay may be unavoidable due to the need to establish a quorum. In order to expedite our ability to begin as soon as a quorum is established, holders of proxies are encouraged to submit them earlier, as per the instructions on the enclosed proxy.

As a member of the County Committee comprising the **7th Civil (Municipal) Court District**, Borough of Brooklyn, City of New York, of the Kings County Democratic County Committee, you have an affirmative duty to participate in this meeting and in the selection of our Party's nominee for the **7th Civil (Municipal) Court District**.
